## Usage and precautions.

1. This product can only be charged with its own charger. The vacuum should always be turned off when charging. The indicator light will be red, indicating that it is charging. The indicator light will change from red to green when the battery is fully charged. Do not continue charging once the indicator light has changed to green.
2. The vacuum is designed to be used for half an hour. After that time, it should be cooled for 10 minutes. Doing this will help prevent damage to the vacuum caused by long-term use.
3. This vacuum is NOT a toy. Please keep all children supervised around the vacuum to avoid danger.
4. This product should be placed in a dry place.
5. After the filter is cleaned, please dry it and reinstall it. Otherwise, it will affect the dust collection effect of the product.
6. Hoses, brushes, and suction nozzles can all be directly plugged into the machine for use. The brush is convenient to absorb stubborn dust.
7. If there is an abnormal noise or smell inside the vacuum cleaner, please stop using it immediately.
8. Do not disassemble the machine privately to avoid danger.
9. It is strictly forbidden to expose the vacuum to the sun for a long period of time. It is strongly advised NOT to leave the machine outdoors or in the car when not in use in summer and winter.
